CALL FOR NOMINATIONS

Make time today to acknowledge an individual or organization that has made outstanding contributions to a senior's quality of life. Nominate them for one of the most prestigious awards in Florida's professional aging network – the Quality Senior Living Awards (QSLA).

Who can submit a QSLA nomination? You! Anyone can nominate a person or organization for an award. Simply read the criteria for each award and think about people or organizations that deserve to be recognized.

How to Submit a Proposal: The submission form is posted on the FCOA website at www.fcoa.org. *All proposals must be submitted electronically by May 24, 2018.*

Package for Award Recipients: Each winner will receive the following package, valued at more than \$400 • Personalized plaque and poster commemorating the presentation of this award • Complimentary Full Conference Registration • One (1) night's lodging at the Marriott Waterside, Tampa • Complimentary individual membership in the Florida Council on Aging for one (1) year.

When will QSLA winners be recognized? Recipients of the 2018 Quality Senior Living Awards will be honored Tuesday, August 14th during the 2018 FPL Florida Conference on Aging Awards Luncheon in Tampa.

When will QSLA winners be notified? Award winners will be notified by June 12, 2018.

Purpose of the QSLA: To recognize individuals and organizations whose efforts have improved the quality of life of older Floridians.

General Criteria for QSLA: The accomplishments of the individual or organization should:

- Benefit Florida's older adults and
- Be deserving of statewide recognition

Award Categories: *All nominees must meet the general criteria stated above and the specified criteria stated for each category below:*

- **Service to Seniors by an Organization Award:** The nominee must be a business, private or public organization that does **not** have service to older adults in Florida as its primary focus. The description of the organization's activities must reflect the monetary value and/or human capital (volunteer or staff time) associated with the services provided to seniors. Organizations can nominate themselves.
- **Senior Vision Media Award:** The nominee must be an individual or organization that has created a media product promoting a positive image of aging. Examples: advertisements, books, posters, billboards, special news coverage, videos, radio and public service announcements and social media.
- **Dr. Carter Osterbind Outstanding FCOA Member Award:** The nominee **must** be an FCOA member in good standing, whose has demonstrated service and support of the Florida Council on Aging, and whose activities on behalf of older adults in Florida reflect a high level of individual commitment or high standard of organizational excellence. Nominees may be individuals or organizations (nonprofit, public or for-profit).
- **Public Service Award:** The nominee can be a volunteer of any age in Florida, in which the area of service can include: seniors in service to seniors, youth in service to seniors or seniors in service to youth. Nominee can be an individual or organization.
